THIS AGREEMENT made the \_\_\_\_ day of MAY 02 2025 2025 between **NATIONAL IRRIGATION ADMINISTRATION**, EDSA, Diliman, Quezon City, Philippines (hereinafter called "the Entity") of the one part and **NEXTGEN TRADING AND SERVICE, INC.**, with principal office address at A1 Unit 18 Global Construct City, Brgy. Panipunan, Mexico, Pampanga, Philippines (hereinafter called "the Supplier") of the other part;

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly **Lot No. 1 - Supply and Delivery of Three (3) units Brand New Excavator, Crawler Long Reach, 0.50 cubic meter (min.), Four (4) units Brand New Tractor Crawler (Bulldozer) 174 Hp (min.), Fifty One (51) units Brand New Loader, Wheeled with Backhoe, 1.1 cu.m. (min.), 0.18 cu.m. (min.) and Seventeen (17) units Brand New Motor Grader 99 Hp (min.) 10ft mold-board of Contract No. NIACO-S-22, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Thirty Five Million Four Hundred Thousand Pesos (PhP435,400,000.00)**, (hereinafter called "the Contract Price").**

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of **Four Hundred Thirty Five Million Four Hundred Thousand Pesos (PhP435,400,000.00)**, or such other sums as may be ascertained, **NEXTGEN TRADING AND SERVICE, INC.**, agrees to Supply and Delivery of Various Brand-New Operation and Maintenance Equipment, in accordance with his/her/its Bid.
  4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
