

Contract Agreement

Contract No. NIACODSD-S-1

THIS AGREEMENT made the 25th day of February 2025 between NATIONAL IRRIGATION ADMINISTRATION, EDSA, Diliman, Quezon City, Philippines (hereinafter called "the Entity") of the one part and SICCION MARKETING, INC., with principal office address at CBS Bldg., 1800 A. Mendoza St., Sampaloc, Manila, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Lot No. 2 – Supply and Delivery of Brand-New GNSS RTK, of Contract No. NIACODSD-S-1, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Million Nine Hundred Ninety Six Thousand Pesos only (PhP5,996,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs)
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental Bid Bulletin No. 1.
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and



3. In consideration for the sum of **Five Million Nine Hundred Ninety Six Thousand Pesos only (PhP5,996,000.00)** or such other sums as may be ascertained, **SICCION MARKETING, INC.**, agrees to supply and deliver one (1) unit brand new GNSS RTK, in accordance with his/her/its Bid.

4. The National Irrigation Administration agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
