CONTRACT AGREEMENT

THIS AGREEMENT made the NOV 21 2022 day of 20 between **NATIONAL IRRIGATION ADMINISTRATION**, with principal office address at NIA Bldg., EDSA, Quezon City, represented by its Deputy Administrator for Administrative and Finance Sector, **RALPH LAUREN A. DU** (hereinafter called "NIA") of the one part and **CERTIFICATION INTERNATIONAL PHILIPPINES, INC.**, with principal office address at 8th Floor, OMM-Citra Building, San Miguel Avenue, Ortigas Center represented by its Chairman, **RENATO V. NAVARRETE** (hereinafter called "CIP") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly *Procurement of Certifying Body for the National Irrigation Administration ISO 9001:2015 Quality Management System for Certification and Recertification* and has accepted a Bid by CIPI for the supply of those goods and services in the sum of **Two Million Seven Hundred Seventy-Three Thousand One Hundred Twenty Pesos Only (Php 2,773,120.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
- ii. Certification International Philippines, Inc.'s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



4. The **NATIONAL IRRIGATION ADMINISTRATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
